- You will receive full information about your options and the care and supports available.
- You can have a support worker or a friend or family member with you for support if you request it.

SART Worker

- A SART worker works on the Sexual Assault Response Team at the Victoria Sexual Assault Centre.
- They provide you with emotional support
- They provide you with information about your options
- They help coordinate services

Medical Care Choices



Victoria Sexual Assault Clinic

The nurse can provide treatment and care for survivors at the clinic



OR

Victoria General Hospital Emergency Department

The hospital may be necessary for severe medical injuries that require the attention of a doctor



With either option a support worker form the Victoria Sexual Assault Centre can attend with you



Remember you can stop or change your mind at any point in this process



Forensic Nurse Examiners

- Forensic Nurse Examiners are specially trained to provide care to survivors of sexual assault, and trained to find and collect evidence if you choose to have them do so.
- The nurse will ask you to sign a consent form for the exam.
- The nurse will ask you some detailed questions about your **medical history** such as past illness or allergies to ensure the best medical care.
- The nurse will ask you some questions about the sexual assault to make sure you receive the most appropriate and best medical care.
- You can have medical care with the Forensic Nurse Examiner for up to 7 days after the assault. If the sexual assault happened more than 7 days ago, you may be referred to Island Sexual Health or your own doctor for medical treatment.

Your Choices

Medication Only

Medication for some common sexually transmitted infections and pregnancy prevention.

Blood and urine samples will be taken with your consent.





Medical Exam

Checking you medically, writing down any injuries, may include both **external** and **internal** and examination.

It is **your choice** which parts of exam you consent to.









Forensic Exam without Police

- A forensic exam is available up to 72 hours after the sexual assault.
- Forensic exam includes the collection of physical evidence, such as hairs, fibers or fluids from your body.
- Evidence will be stored at the hospital for one year
- If you don't want to talk with police right now or are unsure about reporting you can still have evidence collected by a nurse.
- If you are considering reporting to the police, it is helpful to not shower, change or destroy clothing. If you have done any of these things it is **completely normal** and doesn't mean that there isn't evidence that can still be collected.

Even when evidence is not collected or if it has been a long time since the sexual assault happed, you can still report to police if you want to.

Police Involvement



Only you know what the right decision is for you.

You are in control

- You can choose to have **no police** involved and not make a police report.
- You can choose to have evidence collected in case you want to report at a later date.
- You can choose to make a police report while at the clinic or hospital or sometime later.







Forensic Exam with Police

- If you would like to report the sexual assault to police immediately the SART worker will call the police.
- Police will speak with you about the sexual assault.
- Police will take the evidence from the Forensic Nurse Examiner and Police may ask to take your clothing.
- The clinic and the hospital can give you some clothing if yours have been taken for evidence.

Making a Police Report



- It is common to have mixed feelings or feelings of anxiety, uncertainty, or fear about making a police report. These feelings are valid
- In most cases it is your choice if you want to report the sexual assault to the police.
- There is **no time limit** you can make a report at any time.



- If you have not made a report, but think you might like to now or in the future it is helpful to write down everything you can remember.
- A forensic exam is not required to make a police report



- A Victim Service Worker from the Victoria Sexual Assault Centre can support you throughout this process; provide more information about reporting to police and answer any questions you may have.
- If you have made a police report you will be given a **file number** and the names of an officer or detective responsible for your case.
- This file number allows you to get information or updates which you can do at any time.



- Police will investigate your case
- You will give a statement that is taped or recorded
- Police may talk with other people who might know something about the sexual assault



- The police will ask what happened and ask very detailed questions
- Some questions may or may not feel embarrassing or judgmental
- This doesn't mean that they don't believe you
- You can ask questions at any time. It's your right
- The police need to gather as much information as possible for the investigation



- The Victoria Sexual Assault Centre has people that can **go with you** to the police if you need support
- The Victim Service Worker can explain things to you
- You can talk about a safety plan with the SART Worker or by calling the Crisis Line at 250 383-3232

Common Reactions After a Sexual Assault



- It is normal to have many emotions and feelings after a sexual assault.
- You may feel many different emotions and your feelings and reactions may change over time.
- You may experience some or none or all

At the Victoria Sexual Assault Centre, we believe that there is no right or wrong way to feel or behave after a sexual assault.

We believe that **healing** is possible.

It is important to try and be aware of your own needs and look after yourself.

Be patient and gentle with yourself- dealing with a sexual assault can be a long process for some people.

You are not alone. The Victoria Sexual Assault Centre offers support, caring and hope.

Receiving support can be an important part of healing.

The Victoria Sexual Assault Centre offers **free and confidential** counseling and support if you have experienced any form of sexualized violence.

It is not uncommon to reach out for support in a few days, a few weeks, or even years after the sexual assault.
