

Leadership transition

Dear community members,

On behalf of the Board of Directors of the Victoria Sexual Assault Centre (VSAC), we are writing to advise you that Elijah Zimmerman has resigned from the position of Executive Director of VSAC. We share this news with both heavy hearts and joy for Elijah as he moves on to new and exciting endeavours. After a productive month of handovers and wrap-ups, Elijah's last day was January 31, 2023.

Elijah held the position of Executive Director of VSAC for three years. During his tenure, he led the Centre through a global pandemic, changes and updates to the delivery of services, and the collaborative development and implementation of a three-year strategic plan—all the while ensuring that VSAC's work was responsive to, and in solidarity with, the needs and priorities of people and communities most impacted by sexualized violence. Elijah's leadership also oversaw the alignment of VSAC's organizational system with its purpose and values. This included efforts to continue to understand VSAC's role in Truth and Reconciliation, and creating policies and procedures for equity, diversity, and inclusion, with a focus on anti-racism. It is difficult to put into words our gratitude to Elijah for his guidance, insight, and presence while in the role of Executive Director.

As of February 1, we welcomed Samantha Loppie as the Interim Executive Director of VSAC. Coming from the Manager of Direct Client Services position, Samantha has worked closely with Elijah to prepare for her transition into the Interim ED role. We are looking forward to working with Samantha and have high confidence in her leadership and connection to a strong management team at VSAC.

The Board of Directors has begun the search for a new Executive Director. We are hopeful that this process will conclude by April, 2023. We will be sure to introduce the new Executive Director.

Territory acknowledgement

It is our responsibility to address the ways colonial violence and non-consent shape the experiences and impacts of sexualized violence for Indigenous Peoples. As part of our commitment to reconciliation and consent-based relations, we recognize the sovereignty of Indigenous Peoples and the rights and relationship they have to their traditional lands and territories.

Update on charitable status

Thank you for supporting the Victoria Sexual Assault Centre as a donor. We wish to update you about the progress of our reapplication for charitable status.

On October 29, 2022, the Victoria Sexual Assault Centre lost Canada Revenue Agency (CRA) charitable status due to an administrative error. We have rectified the filing error and have submitted our application for reinstatement to our lawyer to review and submit to the Canada Revenue Agency. The CRA has advised that it may take up to six months for them to complete their assessment. The CRA has confirmed that we are able to receive donations but cannot issue tax receipts for them until our status has been reinstated. Upon reinstatement, we will be able to back-issue receipts for any donations made to us.

We apologize for the inconvenience this has caused and hope you will consider continuing your support of the Victoria Sexual Assault Centre during this transitional time. Reopening for in-person counselling

VSAC has continued to adapt to community needs as the pandemic has shifted. In December, VSAC counsellors started coming back into the office regularly to provide in-person counselling, in addition to the virtual counselling services that we continue to provide. This change is allowing us to meet the varying needs of survivors for counselling support.

As part of this shift, we have been considering ways to make our space more welcoming for survivors and reflective of our work with them. We have reopened our reception on an asneeded basis to provide clients with a comfortable space, where we provide warm beverages and a calming environment to settle in before appointments. Our staff also participated in a VSAC beautification initiative, where they decorated eight skateboard decks with uplifting messages to survivors to be hung on our office walls as art. This was to create a more welcoming environment for youth coming to the Centre.

New counselling supervisor

In the fall, VSAC created a new counselling supervisor position to support the counselling team and build service capacity. Kathryn Saunders brings a depth of experience to the position, including crisis counselling, longer-term trauma counselling, and group support at VSAC.



"Part of my work is still to see clients as a counsellor, and the other part of my

work is to support the counselling staff by facilitating team meetings, coordinating case consultations, providing direction and focus, and picking up on themes in the work and keeping the threads together so that we are providing the best services possible for clients." – Kathryn

Program development is a key responsibility of the role. An exciting new program that will be implemented this spring is a drop-in group for survivors, which will be delivered both online and in person. The counsellor supervisor role has made it possible to offer this additional service without reducing the capacity of counsellors to see clients.
